## RULES/REGULATIONS AND RELEASE OF LIABILITY

1. **No negative behavior will be tolerated; disrespect of others (Host/Vendors)!** Failure to comply will result in immediate closure of booth and unable to participate in future events.
2. **NON-REFUNDABLE EVENT.** Please be prepared for the possibility of wind/rain.
3. All booths will be assigned on a "first come, completed registration" and absolutely no booth space will be held without payment of space rental.
4. To ensure variety and to eliminate repetition, the Madelia Area Chamber of Commerce will **limit** the kinds of merchandise sold. There will not be duplicated direct sale vendors.
5. **Booths must be in place one-half hour prior to opening to the public. Be respectful of other vendors, booths are NOT to be taken down until 5:00 pm, you are welcome to stay open longer if you wish.** Vendors may unload prior to 10:00am and load vehicle after 5:00pm at booth location. Vendor parking during the event is available in close proximity.
6. The vendor will be responsible for all set-up equipment needed for their booth including tents, tables, chairs, banners, supplying UL listed extension cords and equipment and other necessary items to provide service. The vendor will be responsible for, if needed, for construction, dismantling, and clean-up of their booth area. All areas are to be kept neat, clean and orderly at all times. If more than reasonable clean-up is required after the vendor departs, an invoice for \$50 for clean-up charges will be sent to the vendor and vendor will not be invited to participate in the Rivers Edge Art & More Fair.
7. No weapons are permitted on the premises, either personal or for sale.
8. No dumping of liquids and water is allowed. Use of storm drains is prohibited. Vendors will be responsible for all fines resulting from code violations.
9. The vendor is responsible for collecting and paying sales tax to the State of Minnesota for the food or products sold, and meeting all state, county and city code requirements.

**Liability and Security** - The Madelia Area Chamber of Commerce, its board of directors and its staff will not be responsible for losses of any kind, whether by fire, theft, physical violent, elements of nature or any other causes whatever their origination. Madelia Park Days will provide minimal security during the event; however vendors will be responsible for their own merchandise and equipment, its protection and its insurance.

**Indemnification** - I have read the Madelia Area Chamber of Commerce vendor policies, procedures, rules, regulations and requirements for application to participate in Madelia Park Days and agree to abide by such. I agree to and hereby assume any and all risks of personal injuries to myself including death and damages to my property caused by or arising from participation in this event. I agree to defend, indemnify and hold the Madelia Area Chamber of Commerce and the City of Madelia harmless from and against any claim, demand, suit, loss, causes of action, damages, liabilities, obligations, costs, expenses and judgments (including without limitation, death and damages to property), caused by my acts or omissions or failure to abide by the rules and conditions contained therein. The Madelia Area Chamber of Commerce, as official promoters and organizers of the event, retains the sole propriety over all aspects of the event, which includes posters, other memorabilia, vendor selections, and reserves the right to final interpretation of all rules.
